ASSIGNMENT

WHEREAS, I, Scott P. Allsup, or his heirs, successors and assigns, to the full ends of the terms for which Letters Patent may be granted.

AND I further grant to James F. Allsup, an individual, his heirs, successors and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.
