ASSIGNMENT

WHEREAS, we, Simone SASSOLINI, Mauro MARCHI, Marco DEL SARTO and Lorenzo BALDO (hereinafter referred to as ASSIGNORS), having mailing addresses of Via Matteo di Giovanni, 19, Sansepolcro, Italy 52037; Via San Sebastiano del Piombo, 23, Milano, Italy 20149; Via Romana, 272, Massa, Italy 54100 and Via Piave, 172, Bareggio Italy, 20010, respectively, are the joint inventors of an invention entitled "METHOD FOR MANUFACTURING A MICRO-ELECTRO-MECHANICAL DEVICE, IN PARTICULAR AN OPTICAL MICROSWITCH, AND MICRO-ELECTRO-MECHANICAL DEVICE THUS OBTAINED," as described and claimed in the specification for which an application for United States letters patent was filed on April 8, 2004 and assigned Application No. 10/821,263. ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks to issue all letters patent on said invention to ASSIGNEE. ASSIGNORS agree to execute all instruments and documents required for the making and prosecution of applications for United States and foreign letters patent on said invention, for litigation regarding letters patent, or for the purpose of protecting title to said invention or letters patent therefor.
