ASSIGNMENT

WHEREAS, I, Christian John Greenfield, citizen of the United States of America; and resident of Oxnard, California, have invented certain new and useful improvements in a "SYRINGE FOR SEQUENTIAL DELIVERY OF DIFFERENT FLUIDS" for which I am about to make application for United States Letters Patent, the said application having been executed on Feb. 27, 2004 and;

WHEREAS, Dr. Chris Johnson, an individual, having offices at 1786 Ocean Oaks Road, Carpinteria, California 93013, ("ASSIGNEE") is desirous of acquiring an undivided fifty percent (50%) interest in and to the invention, and to the application and any Letters Patent that may issue thereon;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I do hereby sell, assign and transfer unto said ASSIGNEE, his successors, assigns, and legal representatives, an undivided fifty percent (50%) interest in and to the invention and in and to said application and all patents which may be granted therefor, and all divisions, reissues, substitutions, continuations, and extensions thereof; and I hereby authorize and request the Commissioner of Patents and Trademarks to issue all patents for the invention, or patents resulting therefrom, insofar as our interests are concerned, jointly to me and to the said ASSIGNEE of said undivided fifty percent (50%) interest.

I also hereby sell and assign to said ASSIGNEE, his successors, assigns, and legal representatives an undivided fifty percent (50%) interest in the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention jointly in our respective names throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and I further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such fifty percent (50%) right, title and interest in ASSIGNEE, his successors, assigns and legal representatives.


I hereby further agree that I will communicate to said ASSIGNEE, or to his successors, assigns, and legal representatives, any facts known to me respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything possible to vest a fifty percent (50%) interest in said ASSIGNEE and to aid said ASSIGNEE, his successors, assigns and legal representatives to obtain and enforce proper patent protection for the invention in all countries.
