

## ASSIGNMENT

WHEREAS, EXXON CHEMICAL PATENTS, INC., a corporation organized under the laws of the State of Delaware, is the owner of record of the granted patents and pending patent applications listed on the attached Attachment 1 ("Patent Assets"); and

WHEREAS, the name of EXXON CHEMICAL PATENTS, INC. was changed to EXXONMOBIL CHEMICAL PATENTS, INC. (hereinafter, "EMCPI" or "Assignor"), as shown in Attachment 2; and

WHEREAS, Richard F. Phillips, Attorney-in-fact of EMCPI, is authorized to execute assignment documents relating to assets owned by EMCPI; and

WHEREAS, the name of EXXON CHEMICAL COMPANY (hereinafter, "ECC"), a division of Exxon Corporation, was changed to EXXONMOBIL CHEMICAL COMPANY (hereinafter, "EMCC" or "Licensor"), a division of Exxon Mobil Corporation; and

WHEREAS, TREDEGAR INDUSTRIES INC. acquired certain rights under the Patent Assets pursuant to the terms of the Technology License Agreement between ECC and TREDEGAR INDUSTRIES INC. ("License Agreement"), having a Closing Date of May 17, 1999; and

WHEREAS, "AFFILIATES" of EMCC as used herein shall have the same meaning as in the License Agreement, and EMCC and its AFFILIATES shall be referred to herein collectively as "ExxonMobil;" and

WHEREAS, the name of TREDEGAR INDUSTRIES INC. was changed to TREDEGAR CORPORATION (hereinafter, "TC" or "Licensee"); and

WHEREAS, TC has assigned the rights in and to certain patents and other intellectual property, including the rights in and to the Patent Assets, to TREDEGAR FILM PRODUCTS CORPORATION (hereinafter, "TFPC" or "Assignee") and intends for TFPC to also take assignment of the Patent Assets hereunder; and

WHEREAS EMCPI, no longer desires to maintain the Patent Assets, and TFPC desires to acquire ownership of the Patent Assets subject to the reservation by EMCPI of an irrevocable, nonexclusive, royalty-free immunity from suit under the Patent Assets for ExxonMobil and ExxonMobil licensees, together with the right to extend such immunity to the direct and indirect customers of ExxonMobil and ExxonMobil licensees, but only to the extent that such customers are practicing any invention claimed in the Patent Assets using resins purchased from ExxonMobil or an ExxonMobil licensee;

NOW THEREFORE, EMCPI, owner of the Patent Assets, hereby assigns all its right, title and interest in and to said Patent Assets to TFPC, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as of May 1, 2004; provided however, EMCPI reserves for ExxonMobil and ExxonMobil licensees an irrevocable, nonexclusive, royalty-free immunity from suit under the Patent Assets, together with the right to extend such immunity to the direct and indirect customers of ExxonMobil and ExxonMobil licensees, but only to the extent that such are practicing any invention claimed in the Patent Assets using resins purchased from ExxonMobil or ExxonMobil licensees. ExxonMobil additionally retains all rights currently held in the Patent Assets under the License Agreement other than ownership and the right to enforce the Patent Assets. Additionally, effective May 1, 2004, ExxonMobil is relieved of its obligations under the License Agreement to prosecute and maintain the Patent Assets.

EMCPI agrees that it will execute any additional documents reasonably necessary to carry out this assignment, including but not limited to special forms of assignment, address changes, Powers of Attorney and other documents that may be required under the patent practices of any country in which any of the Patent Assets is located.

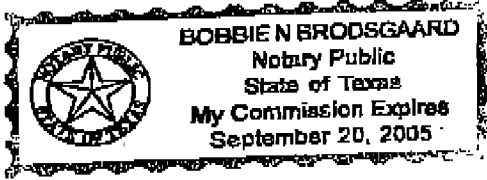

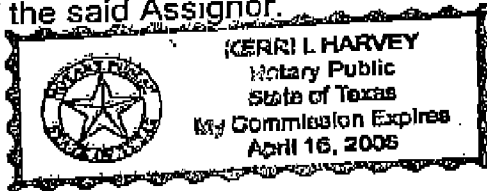

**AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
EXXON CHEMICAL PATENTS INC.**

The present name of the corporation is Exxon Chemical Patents Inc. The corporation was incorporated under the name "Exxon Chemical Marketing Inc." by the filing of its original Certificate of Incorporation with the Secretary of State of the State of Delaware on June 14, 1982. This Restated Certificate of Incorporation of the corporation, which both restates and further amends the provisions of the corporation's Restated Certificate of Incorporation, was duly adopted in accordance with the provisions of Sections 242 and 245 of the General Corporation Law of the State of Delaware and by the written consent of its sole stockholder in accordance with Section 228 of the General Corporation Law of the State of Delaware. The Restated Certificate of Incorporation of the corporation is hereby amended and restated to read in its entirety as follows:

**FIRST:** The name of the corporation is ExxonMobil Chemical Patents Inc. (hereinafter called the "Corporation").

**SECOND:** Its registered office in the State of Delaware is located at 2711 Centerville Road, Suite 400, in the City of Wilmington, County of New Castle. The name and address of its registered agent is Corporation Service Company, 2711 Centerville Road, Suite 400, Wilmington, Delaware 19808.

**THIRD:** The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Delaware.

**FOURTH:** The total number of shares of capital stock which the Corporation shall have authority to issue is one thousand (1,000) with no par value.

**FIFTH:** In furtherance and not in limitation of the powers conferred by statute, the Board of Directors is expressly authorized to make, alter or repeal the by-laws of the Corporation, subject to the power of the stockholders of the Corporation to alter or repeal any by-law whether adopted by them or otherwise.

**SIXTH:** The election of the Board of Directors need not be by written ballot.
