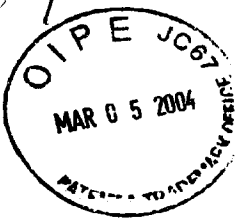

FOR VALUE RECEIVED, we, DAVID GUEVOKIAN, a citizen of Armenia and residing at Ruovedenkatu 13 A 3, FIN-33720 Tampere, Finland; AKI LAUNIAINEN and PETRI LIUHA, citizens of Finland and residing at Yliopistonkatu 45 D 41, FIN-33500 Tampere, Finland; and Jäkäläkatu 30, FIN-33829 Tampere, Finland, respectively, hereby sell, assign and transfer to NOKIA CORPORATION, a corporation duly organized and existing under the laws of Finland, and having a principal place of business at Keilalahdentie 4, FIN-02150 Espoo, Finland, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in METHOD AND SYSTEM FOR PERFORMING A MULTIPLICATION OPERATION AND A DEVICE, which is described in an application for Letters Patent of the United States, Serial No. 10/703,154, filed November 6, 2003, and claiming priority from Finnish Patent Application FI-20021982, filed November 6, 2002; and all the rights and privileges under any and all Letters Patent that may be granted therefor.




