

**WHEREAS, I, JOHN HILBERT**, residing at 3619 W. 187th Street, Torrance, California 90504, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **DIRECT THERMAL PRINTER**, filed on September 26, 2003 as United States Application Number 10/673,044, together with claim to the priority of United States Provisional Application No. 60/414/003, filed September 26, 2002;

**AND I HEREBY** covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

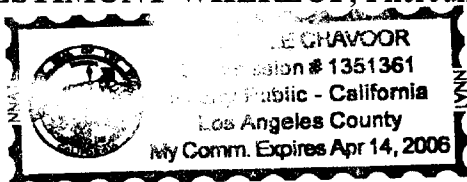


