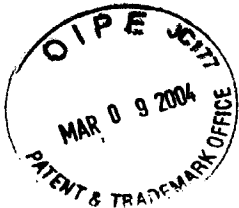

# ASSIGNMENT

WHEREAS, Pascal RUIZ, David TOUSSAINT and Marc SERRA are inventors of an invention subject to United States Patent Application Serial No. 10/687,843 filed October, 20<sup>th</sup> 2003 and entitled "MEDIA SKEW COMPENSATION IN PRINTER DEVICE"
