

And we hereby covenant that we have the full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.


For the same consideration, we, by these presents do sell, assign, and transfer to Alliance Fiber Optic Products, Inc., the full, exclusive, and entire right,
