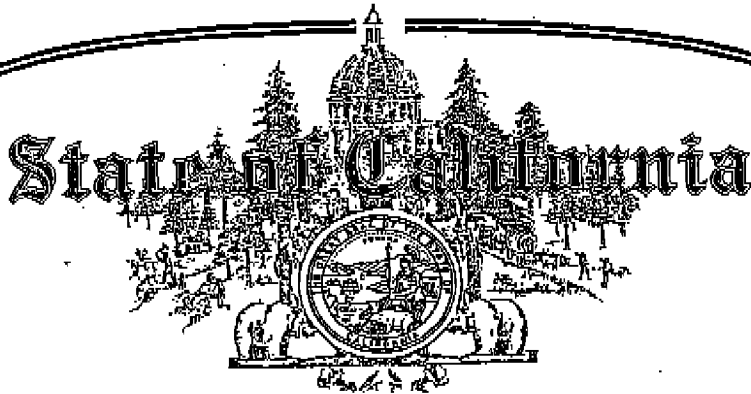

2. Article I of the Restated Articles of Incorporation of the Corporation is amended to read as follows:



The name of this corporation is CHILDREN'S HOSPITAL & RESEARCH CENTER AT OAKLAND".


