**CERTIFICATE OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
TireMinder, Incorporated**

Pursuant to the provisions of the Nevada Revised Statutes, **TireMinder, Incorporated**, a Nevada corporation, adopts the following amendment to its Articles of Incorporation:

1. The undersigned hereby certify that on the 31st day of January, 2003, a Special Meeting of the Board of Directors was duly held and convened at which there was present a quorum of the Board of Directors acting throughout all proceedings, and at which time the following resolution was duly adopted by the Board of Directors:

BE IT RESOLVED: That the Secretary of the corporation is hereby ordered and directed to obtain the written consent of stockholders owning at least a majority of the voting power of the outstanding stock of the corporation for the following purpose:

To amend Article One to provide that the name of the corporation shall be changed from **TireMinder, Incorporated** to **Creative Auto Resources, Inc.**

2. Pursuant to the provisions of the Nevada Revised Statutes, a majority of the stockholders holding 15,824 shares of the 17,857 shares outstanding of **TireMinder, Incorporated** gave their written consent to the adoption of the Amendment to Article One of the Articles of Incorporation as follows:
