PATENT ASSIGNMENT

THIS AGREEMENT is made this 29<sup>th</sup> day of October, 1999 between GEORGE R. BABB, whose address is 25566 Brooklyn Avenue, S.E., Grand Rapids, Michigan 49507 and DIRK A. VANZOMEREN, whose address is 4084 Summit View N.E., Grand Rapids, Michigan 49525.

VanZomereren desires to acquire an undivided one-half interest in Babb's entire right, title and interest in and to U.S. Patent No. 5,858,219 and U.S. Patent No. 5,879,565, as described below, and in the Canadian patent that is presently pending.

For good and valuable consideration, receipt of which is hereby acknowledged, Babb hereby assigns and sells to VanZomereren, and his successors, legal representatives, heirs, assigns and all successors, an undivided one-half interest in his entire right, title and interest in and to U.S. Patent No. 5,858,219 and U.S. Patent No. 5,879,565, and to any and all expansions (including the present expansion that is pending), reissues or extensions of the patents along with the right to sue for past, present and future infringement. Further, Babb hereby assigns and sells to VanZomereren, and his successors, legal representatives, heirs, assigns and all successors in interest an undivided one-half interest in his entire right, title and interest in and to the patent that is presently pending before the patent authorities in Canada and to any and all reissues or extensions of the patents along with the right to sue for past, present and future infringement.

Babb agrees that he will at any time upon the request and at the expense of VanZomereren, execute and deliver any and all papers that may be necessary or desirable to perfect VanZomereren's interest in the above listed patents in such form as may be recordable at the United States Patent and Trademark Office.
