

ASSIGNMENT

This Assignment is being executed this 31st day of August, 1999 by Mark Ortiz ("Assignor") for the benefit of IDx Medical, Ltd., an Ohio limited liability company ("IDx"), pursuant to that certain Consulting Agreement by and between Assignor and IDx.

Recitals

IDx and Assignor have entered into a Consulting Agreement pursuant to which Assignor has been engaged to provide certain consulting services to IDx in connection with the design and development of certain intellectual property.

Pursuant to the terms of the Consulting Agreement, Assignor agreed that all works which may be subject to copyright and all patentable and unpatentable inventions, discoveries and ideas which are made, conceived or written by Assignor during the term of the Consulting Agreement and for 90 days after its expiration, which are based on the services performed by Assignor for IDx in the area of kinetic retractors or similar devices or technology permitting manipulation or presentation of the heart for surgical access during coronary bypass or other heart surgery ("Developments"), are and shall become the sole and exclusive property of IDx.

Assignor further agreed in the Consulting Agreement to execute all papers which may be necessary or advisable to prosecute applications for patents and to vest in IDx, or its designee, all the right, title and interest in and to the Developments.

In connection with the prosecution of patent applications number 08/936,184, 09/087,511 and 09/109,924 related to and/or arising out of the Developments, IDx is requesting and Assignor is desirous of executing this Assignment.

Now therefore, in consideration of the foregoing and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, transfer and convey to IDx all of Assignor's right, title and interest in and to the Developments and all Letters Patent of the United States to be obtained therefor in respect of the patent applications related thereto and in all foreign countries to be obtained for the Developments or any portion thereof, and any continuation, division, renewal, substitute or reissue thereof or any legal equivalent thereof in any foreign country for the full term or terms for which the same may be granted.


