ASSIGNMENT

WHEREAS, we, **Teruhiko Tobinai and Kazuhito Fujisawa**, have invented certain improvements in an **Ink Flow Control Device For Ink Jet Type Printer**, for which we are about to make application for Letters Patent of the United States of America; and

We further authorize said corporation to apply for foreign patents on said invention in its own name or through its designees, including subsidiaries, related companies or assignees, under the International Convention or otherwise, we further agree to execute all papers, including those required for the United States and foreign applications, and to perform such other proper acts as said corporation may deem necessary to secure to said corporation or its designees the rights herein assigned.
