**RELEASE OF PATENTS**

THIS RELEASE OF PATENTS is dated as of August 10, 2004 by GE Business Capital Corporation f/k/a Transamerica Business Capital Corporation, a Delaware corporation , as Agent ("Agent").

WHEREAS, Agent and LYON METAL PRODUCTS, L.L.C., a Delaware limited liability company ("Grantor") entered into that certain Patent Security Agreement (the "Patent Security Agreement"), dated as of August 20, 2001;

WHEREAS, the Patent Security Agreement granted, assigned and conveyed to Agent for collateral purposes all of Grantor's right, title and interest in and to certain patents, patent registrations and patent applications (the "Patents") including, without limitation, the Patents listed on Schedule A attached hereto as security for certain obligations of Grantor to Agent (the "Obligations"); and

WHEREAS, Grantor has satisfied all of the Obligations and has requested that Agent release its security interests in the Patents.

1. Agent hereby, without representation, warranty or recourse, fully releases, terminates, assigns to and reinvests in Grantor all of Agent's right, title, interest and liens granted by the Patent Security Agreement in and on:

(a) all of Grantor's now existing or hereafter acquired right, title and interest in and to: all Patents which are now filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (i) any renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which said Patents have appeared and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world;

(b) the goodwill of Grantor's business connected with or symbolized by Patents; and

(c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Grantor against third parties for infringement of the Patents or of any license with respect thereto.


2. Agent further agrees, at the sole cost and expense of Grantor, to perform all acts reasonably necessary to effect the release and termination of its security interest and
