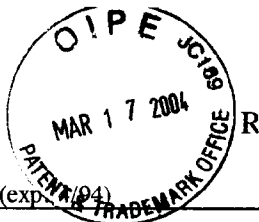

ASSIGNMENT AND AGREEMENT

FOR VALUE RECEIVED, I, CHRISTOPHER M. OSGOOD, citizen of the **United States**, and residing at **38 Terrace Villas, Fairport, New York 14450**, hereby sell, assign and transfer to **ITT Manufacturing Enterprises, Inc.**, a corporation duly organized and existing under the laws of Delaware and having a principal place of business at 1105 North Market Street, Suite 1217, Wilmington, Delaware 19801, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in a **ROTATING MACHINE HAVING A SHAFT INCLUDING AN INTEGRAL BEARING SURFACE**, which is described in an application for Letters Patent of the United States, **Serial No. 10/718,032** filed **November 19, 2003**; and all the rights and privileges under any and all Letters Patent that may be granted therefor.

I request that any and all patents for said inventions be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.



be required in any country for any purpose and more particularly in proof of the right of the said assignee or nominee to claim the aforesaid benefit of the right of priority provided by: (a) the International Convention for the protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any treaty which may henceforth be substituted for it.


