ASSIGNOR further agree that, when requested, he will without charge to ASSIGNEE, its successors, assigns and legal representatives or nominees, but at ASSIGNEE's expense, execute all papers, take all rightful oaths, communicate and provide to ASSIGNEE, its successors, assigns and legal representatives or nominees all facts and documents relating to said INVENTION or history thereof as may be known or accessible to ASSIGNOR, testify as to the same in any interference or litigation related thereto, and generally do all acts that ASSIGNEE, its successors, assigns and legal representatives or nominees may deem desirable for securing, obtaining, maintaining, and/or enforcing or protecting said INVENTION, APPLICATION and/or letters patent therefore in any and all countries of the World, and for vesting title thereto in ASSIGNEE, its successors, assigns and legal representatives or nominees.

ASSIGNOR covenant to ASSIGNEE, its successors, assigns and legal representatives or nominees, that the rights, properties and privileges herein conveyed are free and clear of any encumbrance, and that that they have the full right to convey the same as herein expressed.
