WHEREAS, I, Dr. B. J. Thal, having been duly appointed as Personal Representative of the Estate of Gail Bereny, desire to transfer certain United States Patents, as hereinafter described, obtained and owned by Bruce D. Rubin at the time of his death and assigned to the Estate of Gail Bereny;

WHEREAS, in accordance with the laws of the State of Washington, I desire to transfer said patents in equal shares to Planned Parenthood of Western Washington, c/o Ms. L. Arendt, 2001 East Madison Street, Seattle, Washington 98122, and to Jewish Federation of Greater Seattle, c/o Mr. George Parker 2031 3<sup>rd</sup> Avenue, Seattle, Washington 98121, the devisees jointly entitled to ownership of said patents;

WHEREAS, said patents are identified as United States Patent No. 5,934,676, entitled Craps Game Table Having Event Summary Display, granted August 10, 1999, and United States Patent No. 5,857,909, entitled Computerized Roulette Game Table, granted January 12, 1999 (hereafter "Rubin Patents");

WHEREAS, Bruce D. Rubin prior to his death entered into a License Agreement dated June 25, 2001, relating to U.S. Patent No. 5,857,909, in which Mr. Rubin, upon certain terms and conditions granted certain rights to WMS Gaming Corp., and such License Agreement is assignable and may be assigned to the Estate of Gail Bereny and further assigned to Planned Parenthood of Western Washington and Jewish Federation of Greater Seattle in equal shares;

NOW, THEREFORE, I hereby assign and transfer unto Planned Parenthood of Western Washington and Jewish Federation of Greater Seattle, in equal shares, the entire

right, title and interest in and to the Rubin Patents including all reissues, re-examinations, and extensions thereof which may be granted until the end of the terms of said patents;

I hereby assign, and transfer all rights and obligations of Bruce Rubin set forth in the License Agreement to Planned Parenthood of Western Washington and Jewish Federation of Greater Seattle;

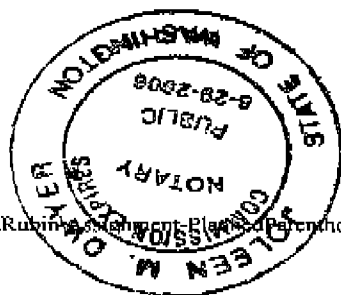
