This Assignment made by me, **Ian J. Forster**, hereinafter referred to as assignor, a citizen of the United Kingdom, residing at 31 Great Cob, Chelmsford, Essex, CM1 6LA, United Kingdom;

WITNESSETH: That,

WHEREAS, I am the sole inventor of certain new and useful improvements in **REFLECTIVE COMMUNICATION USING RADIO-FREQUENCY DEVICE**, for which I have applied for Letters Patent of the United States on April 25, 2003, Application Serial Number 10/423,824.

assigns, to the full end of the term for which said Letters Patent may be granted as fully and entirely as the same would have been held and enjoyed by me had this assignment and sale not been made.

And for the consideration aforesaid, I hereby covenant and agree to and with the said assignee, its successors and assigns, that at the time of the execution and delivery of these presents I am the sole and lawful owner of the entire right, title and interest in and to the invention, application and Letters Patent above-mentioned and that the same are unencumbered, and that I have good right and lawful authority to sell and convey the same in the manner herein set forth.
