ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT is entered into as of July 22, 2004, by and among Alan R. Pfaff Jr., an individual (the "Assignor"), and Eagle Rotary Systems, Inc., a Michigan corporation (the "Assignee").

Recitals

1. The Assignor hereby assigns, sets over and transfers to the Assignee all of the Assignor's right, title and interest in, and any and all rights and privileges associated with the Patent Application provided under the laws of the United States, or the individual States thereof, and of jurisdictions foreign thereto, and the right to bring suit and collect damages for past infringements thereof.



Assignor hereby covenants and agrees that Assignor will at any time upon the request and at the expense of the Assignee execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect said right, title, and interest and said rights and privileges in Assignee, its successors, assigns and legal representatives.

This Agreement and the obligations of the parties hereunder shall be binding upon and inure to the benefit of the parties hereto, their respective successors and permitted assigns, and shall be governed by and construed in accordance with the laws of the State of Michigan. This Agreement constitutes the entire agreement among the parties and may not be modified or amended in any manner other than by a written agreement signed by all of the parties to this Agreement.

4. This Agreement may be executed in any number of counterparts, but all such counterparts shall be deemed to constitute one and the same instrument.




