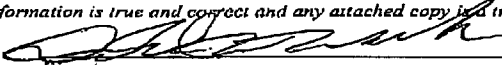

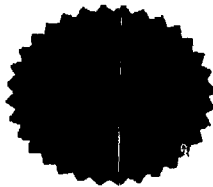

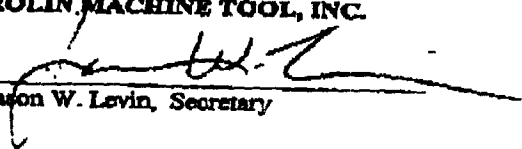
FIRST: That the Certificate of Incorporation of the Corporation is hereby amended by striking paragraph **FIRST** as it is and inserting in lieu thereof the following:
