RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS is dated as of September 1, 2004 by GENERAL ELECTRIC CAPITAL CORPORATION (f/k/s SunTrust Bank, Atlanta), as Agent ("General Electric").

WHEREAS, General Electric and Anthony, Inc., f/k/a New Anthony, Inc., a Delaware corporation, ("Borrower") entered into that certain Collateral Assignment and Patent Security Agreement ("Agreement") dated as of December 22, 1998;

WHEREAS, the Agreement granted General Electric a security interest in, among other things, inventions, discoveries and ideas, whether patentable or not, and all patents, registrations, and applications therefor, and any licenses with respect thereto (collectively, the "Patents") including, without limitation, the Patents listed on Schedule A attached hereto as security for certain obligations of Borrower to General Electric (the "Obligations"); and

WHEREAS, General Electric recorded the Agreement on July 26, 2000 at Reel 10977, Frame 0740 in the United States Patent and Trademark Office; and

WHEREAS, concurrent with Borrower's satisfaction of the Obligations, Borrower has requested that General Electric release its security interests in the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, General Electric hereby agrees as follows:

1. General Electric hereby fully releases and terminates its security interests in and liens on the following (collectively, the "Patent Collateral"), whether granted pursuant to the Agreement, or any other document or agreement, and whether or not recorded with the United States Patent and Trademark Office:

(a) all of Borrower's now existing or hereafter acquired right, title and interest in and to: all Patents listed on Schedule A attached hereto, all Patents which are now filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and all other Patents, and (i) any divisions, continuations, continuations-in-part and renewal applications, and any extensions, reissues and renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which said Patents have appeared and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world;

(b) the goodwill of Borrower's business connected with or symbolized by Patents; and

(c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Borrower against third parties for infringement of the Patents or of any license with respect thereto.


2. General Electric, on its own behalf and on behalf of the Lenders, hereby reassigns to Borrower, without recourse, representation or warranty, any right, title and interest of General Electric and the Lenders, if any, in and to the Patent Collateral.

3. General Electric further agrees, at the sole cost and expense of Borrower, to perform all acts reasonably necessary to effect the release and termination of its security interest and liens, including, but not limited to the recording, filing and entering into any agreements, documents, forms or papers needed to accomplish such release and termination.
