

enforcing all lawful patent or other grants of protection of said inventions in any and all countries and regions.



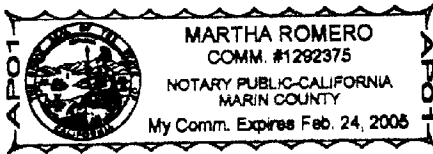

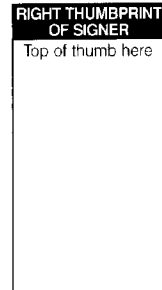
