**ASSIGNMENT**

WHEREAS, we, Harald Relling and Jan Lade, both of Ikornnes, Norway, respectively, have invented certain improvements in a SEATING ARRANGEMENT AND SIDE MEMBER, for which we have executed an application for Letters Patent of the United States, filed with the United States Patent and Trademark Office on October 7, 2002 and assigned Serial No. 29/168,772.

WHEREAS, Ekornes ASA, a Norwegian corporation, having its principal place of business in Ikornnes, Norway, is desirous of acquiring an interest therein:

We hereby authorize and request the Patent Office officials in the United States to issue any and all of said Letters Patent, when granted, to the said Ekornes ASA, as the assignee of our entire right, title and interest in and to the same, for the sole use of the said Ekornes ASA, its successors and assigns.

Further, we agree that we will communicate to the said Ekornes ASA, or its representatives any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal

and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to the said Ekornes ASA, make all rightful oaths and generally do everything possible to aid the said Ekornes ASA, its successors and assigns, to obtain and enforce proper protection for said invention in the United States.
