ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT ("Agreement") is made and entered into as of 30 March, 2004 (the "Effective Date") by:

(2) Collin A. Rose, an individual residing at 6147 Olympia Drive, Houston, Texas, 77057, UNITED STATES OF AMERICA ("ASSIGNEE").

The parties, intending to be legally bound agree as follows:

WHEREAS, the ASSIGNORS are the owner of an invention in "Folding Device of Glasses" (hereinafter referred to as "ASSIGNORS Invention");

WHEREAS, the ASSIGNORS are the owner of the following:

(All hereinafter referred to collectively as the "ASSIGNORS Patents/Application"); and

WHEREAS, ASSIGNEE is desirous of acquiring ASSIGNORS' entire right, title, and interest in and to the ASSIGNORS Invention and Patents/Application.

NOW, THEREFORE, for good and valuable consideration, ASSIGNORS hereby assign, sell, and convey to ASSIGNEE, ASSIGNEE's successors, and ASSIGNEE's assigns, ASSIGNORS' entire right, title, and interest throughout the world in and to:

1. Said ASSIGNORS Invention;
2. Said ASSIGNORS Patents/Application;

3. All applications for patent or like protection on said ASSIGNORS Invention, including said ASSIGNORS Patents/Application that have now been or may in the future be made by ASSIGNORS or their legal representatives, including any continuation, continuation-in-part, or any other patent applications that may be based on the ASSIGNORS Invention, ASSIGNORS Patents/Application, whether in the United States of America or any other place anywhere in the world;

4. All patents and like protection that have now been or may in the future be granted on said ASSIGNORS Invention, including said ASSIGNORS Patents/Application to ASSIGNORS or their legal representatives, whether in the United States of America or in any other country or place anywhere in the world;

5. All substitutions for and divisions, continuations, continuations-in-part, renewals, reissues, extensions, and the like of said ASSIGNORS Patent/Applications and like grants, including without limitation, those obtained or permissible under past, present, and future laws and statutes;

6. All rights of action on account of past, present, and future unauthorized use of said ASSIGNORS Invention and ASSIGNORS Patents/Application and for infringement of said ASSIGNORS Invention, ASSIGNORS Patents/Application, and like protection;

7. The right in ASSIGNEE to file in its name applications for patents and like protection for said ASSIGNORS Invention or ASSIGNORS Patents/Application in the United States of America or any other place anywhere in the world; and

8. All international rights of priority associated with said ASSIGNORS Invention, ASSIGNORS Patents/Application, and like protection.

ASSIGNEE, upon signing this Agreement, agrees to pay the ASSIGNORS US\$125,000.00 to a bank account designated by the ASSIGNORS as per the Escrow Agreement executed on 30 March 2004.

ASSIGNORS warrant that all and any of the rights set out in 1 to 8 are free of any incumbrances.

ASSIGNORS hereby further agree that they will communicate to said ASSIGNEE, or to its successors, assigns, and legal representatives, any facts known to it respecting the ASSIGNORS Invention and ASSIGNORS Patents/Application, and at the expense of said ASSIGNEE, it successors, and assigns, testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, and substitute applications, make all lawful oaths, and generally do everything possible to aid said ASSIGNEE, its successors, assigns, and nominees to obtain and enforce proper patent protection in all countries insofar as ASSIGNORS' interest being assigned hereunder and not otherwise reserved is solely concerned.

This Agreement is governed by the laws of United States of America. This Agreement is executed in both English and Chinese languages. In case of any discrepancies between the two versions, the English version shall prevail.

IN WITNESS WHEREOF, the parties have caused this Agreement to be executed by their duly authorized representatives as of the Effective Date.
