## ASSIGNMENT

I, Thomas Aaron Winslow, who resides at 1204 Meadowview Drive, Salem, Virginia, 24153, have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America entitled

### APPARATUS, METHODS AND ARTICLES OF MANUFACTURE FOR POWER AMPLIFIER CONTROL AND FRONT END MODULES IN A COMMUNICATION SYSTEM

2. Authorize Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries in my name or in the name of Assignee or otherwise as Assignee may deem advisable, under the International Convention or otherwise;

3. Authorize and request the Commissioner of Patents of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patent


to Assignee, as assignee of the entire right, title and interest therein or otherwise as Assignee may direct;
