ASSIGNMENT

WHEREAS, Jerry M. Phlippeau, residing in Peru, Illinois, hereinafter referred to as ASSIGNOR, has invented a new and useful

ILLUMINATED ARTICLE

ASSIGNOR hereby authorizes and requests the DIRECTOR OF THE UNITED STATES PATENT AND TRADEMARK OFFICE to issue the United States Letters Patent on said invention, when granted, to Flipo Group Limited.

This assignment shall inure to the benefit of ASSIGNEE, its successors, assigns and other legal representatives, and shall be binding upon ASSIGNOR, ASSIGNOR'S heirs and legal representatives.
