giving of testimony that is deemed necessary or desirable by ASSIGNEE, its successors, assigns or other legal representatives with regard to the Arista Wireless Patents for protecting, obtaining, maintaining and enforcing any and all of said Letters Patent for the Arista Wireless Patents and for perfecting, affirming, recording and maintaining the title of ASSIGNEE, its successors, assigns or other legal representatives and generally cooperate to the fullest extent in all matters pertaining to the Arista Wireless Patents, any and all of said Letters Patent and the title thereto in ASSIGNEE, its successors, assigns or other legal representatives. ASSIGNOR agrees and acknowledges that this Assignment to ASSIGNEE includes without limitation, all income, royalties, damages and payments now or hereafter due or payable with respect to said Arista Patents, and to all causes of action (either in law or in equity) and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Assignment.
