WHEREAS, We, Harald Kerschbaumer residing at Gugger-Nussbaum 35, A-6833 Klaus, Austria, Gottfried Rohner residing at Forststrasse 6, CH-9450 Altstätten, Switzerland, and Walter Pokorny residing at Faschinastrasse 52, A-6712 Thuringen, Austria have invented certain new and useful improvements in AN INTRA-ORAL CAMERA AND A METHOD FOR USING SAME for which an application for Letters Patent of the United States of America was executed on the date which appears next to our signatures, and




