PATENT ASSIGNMENT

The following Agreement is by and between ROBERTA P. "POLLY" STOWE (hereafter Assignor), currently residing at 7100 Airline Road, Airline Trailer Park, #355 Continental, Midland, Texas 79712, representing herself, and further represented by SANDRA FITZPATRICK, Power of Attorney, and WATER VISIONS, INC., by ROBERT W. PERRY, President, (hereafter Assignee) a New Mexico corporation, having its principal office and place of business at 2442 Cerrillos Road, #474, Santa Fe, New Mexico 87505.

WHEREAS, Assignor owns an 100% interest in the United States Patent No. 5231954 titled HYDROGEN/OXYGEN FUEL CELL, and Canadian Patent No. 2141880 similarly titled, and Mexican Patent No. 183455 similarly titled, (hereafter "The Patents") and,

WHEREAS, ROBERTA P. STOWE now intends to enter into an agreement to assign her full 100% ownership in patent rights, to WATER VISIONS INC., inclusive of all rights, title and interest in the invention, and the Patents,

NOW, the parties agree as follows:

1. Assignment. Assignor does hereby assign to Assignee all rights, title, and interest, including but not limited to, the full patent claims, along with sole right to prepare derivative works, all goodwill and all other rights, including but not limited to, sole rights to research, development, distribution, sales, manufacture, advertising, licensing and any and all other rights in and to the patents and the invention that Assignor owns.
2. Consideration. In consideration for the assignment set forth in Section 1, Assignee shall:

(a) Pay to ROBERTA P. STOWE the sum of \$100,000.00 under the following terms and conditions:

1. An initial payment of TEN THOUSAND DOLLARS (\$10,000.00), due sixty days (60) after the date of execution of this agreement, dependant upon the execution of a separate document between Water Visions Inc.

2. A second payment due within six (6) months of the initial payment, h
the amount of TEN THOUSAND DOLLARS (\$10,000.00), and,

3. Four (4) annual installments of TWENTY THOUSAND DOLLARS (\$20,000.00) to ROBERTA P. STOWE, due each year on the anniversary of the second payment and,

(b) Pay to ROBERTA P. STOWE, a 5 percent royalty on the net profit of each product sold covered by the Patents. Net Profit being defined as sale price of the product minus production, sales and delivery costs and expenses.

Assignee shall pay all dividends by company check, to Assignor ROBERTA P. STOWE at her current mailing address within THIRTY (30) days following the last day of each quarter, or in any other manner of delivery that ROBERTA P. STOWE or SANDRA FTIZPATRICK,

acting in her behalf, shall direct. Modification to the manner in payment should be submitted to the main office of WATER VISIONS INC., thirty days prior to the end of each quarter.

3. Entire Agreement This Agreement, contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties, real or assumed, between them, respecting the subject matter hereof.
4. Amendment. This Agreement may be amended only by a writing signed by both parties.
5. Severability. If any term, provision, covenant or condition of this Agreement, or the application thereof to any person, place or circumstance, shall be held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Agreement and such term, provision, covenant or condition as applied to other persons, places and circumstances shall remain in full force and effect.
6. Agreement to Perform Necessary Acts. Assignee agrees to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement.
7. Governing Law. This Agreement shall be construed in accordance with, and all actions arising hereunder shall be governed by, the laws of the State of New Mexico.
8. Binding on Heirs This agreement shall be binding upon the heirs, successors and assigns of the respective parties.

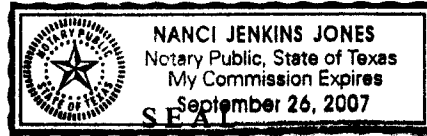

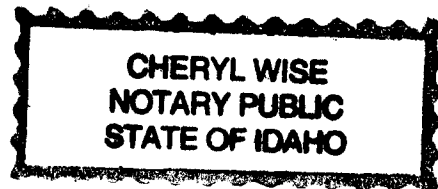

AFFIDAVIT

JON C. CONNER

I, Jon C. Conner, reside at 4965 Iron Springs Rd., Prescott, Arizona, 86305. I am of legal age and of competent mind.

I was a close personal friend and business partner of Gene B. Stowe, also known as Dink Bates Stowe, who was deceased on March 23, 1996. Prior to his death, Gene invented and developed a technology known as the "Hydrogen/Oxygen Fuel Cell," which was patented under his own name as an eighty percent owner and with myself as twenty percent owner. The United States Patent Office registration number is 5231954. The patent was also registered in the country of Canada and numbered 2141880, and in the country of Mexico under the number 183455.

Gene Stowe was married to Roberta P. "Polly" Stowe. Roberta filed to probate Gene's will, and to be named personal representative of the estate on August 12, 1996. Roberta filed an inventory of assets with the Superior Court of Arizona, County of Maricopa on April 23, 1997. The patent ownership is shown on the inventory as issued to Gene B. Stowe and Jon C. Conner, and valued at Two Hundred and Twenty Thousand Dollars. At the time of his death, Gene and Roberta jointly owned Eight Hundred and Eighty Thousand shares of a company known as "International Water Fuel," (incorporated in the State of Arizona in 1993) who manufactured and sold the fuel cells. International Water Fuel was dissolved as an Arizona Corporation in 2002.

Gene left sixty four percent of his shares in International Water Fuel to Roberta, fifteen percent to Gary Stowe, his son from another marriage, and the remaining ten percent to two other parties in equal shares.

Sometime prior to April 21, 2002, Gary Stowe contacted me and asked me to assign my twenty percent ownership of the patents to him. He offered to give me twenty percent of all royalties he would himself receive from "Water Fuel International," dependant upon his ability to receive a patent assignment for the other percentage of ownership, then held by Roberta. Gary alleged to me that Roberta intended to, or had already, assigned her share to Gary.

I did assign my authority of ownership in the patents to Gary Stowe, in exchange for a twenty percent portion of the royalties Gary would receive from Water Fuel International Inc. I have never received any cash payment, goods, or services from Gary or from Water Fuel International, or any other form of remuneration that could be considered as royalties from the sales of the technology.

I have examined a document entitled "Assignment." This document is signed on May 15, 2002 by Gary Stowe. It appears that Gary's intent at that time was to convey the full one hundred percent ownership of the patents to Water Fuel International. The document does not direct itself to royalties, or any other issue.

I have also examined a document entitled "Assignment of Interest in Patent," which appears to be transfer of authority of the patents from Roberta to Gary. I am aware that Roberta states she also has never received any royalties from Gary.


It is now my intent to withdraw my assignment of authority given to Gary in 2002. It is my further intent to transfer my twenty percent ownership solely and irrevocably to Roberta Stowe, the terms and conditions of this transfer will be set forth in a separate document.



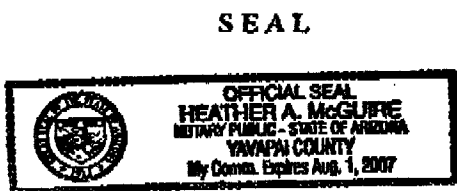

AFFIDAVIT

I, Roberta P. "Polly" Stowe, reside at 7100 Airline, Airline Trailer Park, #355 Continental, Midland, TX, 79712. I was married to Gene B. Stowe, also known as Dink Bates Stowe, who was deceased in March, 1996. During his lifetime, Gene developed and patented a device known as the "Hydrogen/Oxygen Fuel Cell." The device was patented in the United States, Canada and Mexico. When Gene passed, I inherited the majority of the share of ownership, with a family friend, Jon C. Conner, holding ownership of the remaining shares.

My step-son, Gary Stowe, has apparently alleged that I signed an assignment of patent to him in 2002. I disagree with him, I have no knowledge of signing the agreement, and did not intend to sign my ownership to him at any time. I have examined the document purported to bear my signature, and I have verified that the document is not notarized, and does not bear witness signatures.

The document appears to be contingent upon two issues, firstly, being that the document refers to a separate "Purchase and Sale Agreement," which nulls the alleged "Patent Assignment," in the event Gary Stowe is not able to become 100% owner of the device.

It appears the intent of the "Purchase and Sale Agreement" is to assign the patent rights to a company known as "Water Fuel International," and for that company to pay royalties to Gary Stowe on the sale of the device. It also appears that Gary Stowe is the president of Water Fuel International.

I do not believe I signed this document, and it is my intent to retain ownership and full authority over the ownership of the patents, which are filed in the United States under the patent number 5231954, in Canada under the patent number 2141880, and in Mexico, under the patent number 183455. I did not ever intend that Gary Stowe would have ownership or even limited use of the ownership of the patent.

It is my further intent, that as of the date of the signing of this document, to cancel and revoke any and all authorization of power of attorney that I have given to any person. I am a competent and sane adult person, and I am able to deal with my own affairs and issues.

It is my further decision to make a record of my future intent with regard to the patent authorities. I intend to enter into an agreement with Water Visions Inc., a private company, for the development, manufacturing and marketing of the device, and I do not intend that any other person or corporation should exercise any authority, or attempt to exercise authority over ownership of the patents, the device, or its manufacture or sales.

It is my further intent that this document should also act as notice of my personal directives in the event that I should become incapacitated or for any other reason become unable to attend to my personal and financial affairs, that my daughter Sandra Fitzpatrick be appointed my representative, and that she had full control of my assets and property, inclusive of the patents.

I intend that she should continue to uphold my agreement with Water Visions Inc., and to act in my behalf to ensure that no other person attempts to interfere in my designation regarding the patents, or the performance of my agreement with Water Visions Inc.

I intend to make a separate will and testament that will detail more fully my plans for distribution of my property, but want to expressly state here that I did not, and do not, want Gary Stowe to have assignment, ownership, or any authority in any form, over my ownership of the patents, or my right to do as I see fit with the patents.

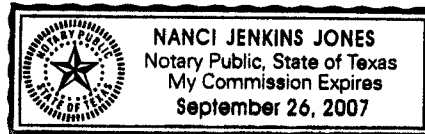

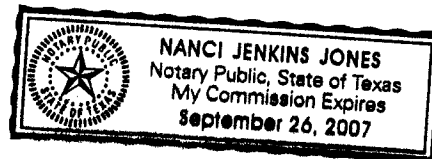
