## ASSIGNMENT

WHEREAS, I, **BERGE H. ASLANIAN**, a citizen of the United States of America, residing at 8461-24 Via Mallorca, La Jolla, CA 92037, hereinafter referred to as "Assignor," have made new and useful improvements in a **CELLULAR TELEPHONE SYSTEM INCLUDING A MULTI-FUNCTIONAL BASE UNIT WITH MANAGEMENT WIRELESS TELEPHONE DATA CAPABILITIES**, for which an application for Letters Patent was filed on June 9, 2004 and assigned Serial No. 10/865,492.

4. Warrant that we have not knowingly conveyed to others any right in said inventions, discoveries, applications, or patents or any license to use the same or to make, use, or sell anything embodying or utilizing any of said inventions or discoveries; and that we have good right to assign the same to Assignee without encumbrance.

5. Bind our heirs, legal representatives, and assigns, as well as ourselves, to do, upon Assignee's request and at Assignee's expense, but without additional consideration to us or them, all acts reasonably serving to assure that the said inventions and discoveries, the said patent applications, and the said Letters Patent shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by us, our heirs, legal representatives, and assigns if this assignment had not been made; and particularly to execute and deliver to Assignee all lawful application documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by Assignee; to communicate to Assignee all facts known to us relating to said inventions and discoveries or the history thereof; to furnish Assignee with any and all documents, photographs, models, samples, and other physical exhibits in our control or in the control of our heirs, legal representatives, or assigns which may be useful for establishing the facts of our conception,


