ASSIGNMENT

WHEREAS, We, Sarvesh Asthana, a citizen of India, and resident of San Diego, California and Andy Xiaodong Chen, a citizen of P.R. China and resident of San Diego, have invented certain new and useful improvements in "APPARATUS, AND ASSOCIATED METHOD, FOR FACILITATING COMMUNICATION OF PACKET DATA IN A PACKET RADIO COMMUNICATION SYSTEM" disclosed in an application for United States Letters Patent (Application No. 10/744,950, filed on December 22, 2003);

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I will communicate to said Assignee, its successors, legal representatives and assigns, any facts known to me




