ASSIGNMENT

We, Bruce K. Zoitos, residing in the City of Buffalo, the State of New York, Michael J. Andrejcek, residing in the City of Niagara Falls, the State of New York, and Paul M. Boymel, residing in the City of Amherst, the State of New York, have invented certain new and useful improvements in HIGH TEMPERATURE RESISTANT VITREOUS INORGANIC FIBER and Unifrax Corporation, a corporation organized and doing business under the laws of the State of Delaware, having a place of business at 2351 Whirlpool Street, Niagara Falls, New York, desires to acquire the rights to this invention.

In consideration of one dollar (\$1.00), receipt and sufficiency of which is hereby acknowledged, and other good and valuable considerations, we, Bruce K. Zoitos, Michael J. Andrejcek, and Paul M. Boymel, hereby sell, assign, and transfer to Unifrax Corporation, its successors and assigns, the entire right, title, and interest in and to this invention relating to HIGH TEMPERATURE RESISTANT VITREOUS INORGANIC FIBER and any improvements thereon; the so-entitled application for United States Letters Patent which was filed on June 25, 2004, which bears United States Serial No. 10/877,278 and file number UNF.P.9354; any and all continuations, continuations-in-part, divisions and renewals thereon; all reissues or extensions thereof; all United States Letters Patent granted thereon; and any and all Letters Patents on said invention, and applications therefor, including all rights to claim priority, in any and all countries foreign to the United States of America.

We hereby authorize and request the Commissioner of Patents and Trademarks of the United States to issue all United States Letters Patent on said invention and application, or applications resulting therefrom, to Unifrax Corporation, as assignee of the entire right, title, and interest.

We further agree that during and subsequent to our employment with Unifrax Corporation, on request and without further consideration, but at the sole expense of Unifrax Corporation, we will with respect to this invention and this application or any subsequent application on this invention communicate to counsel for Unifrax Corporation, its successors and assigns all facts known to me; testify in all legal proceedings; sign all lawful papers; execute all applications; make all rightful oaths; generally do everything possible to aid Unifrax Corporation, its successors and assigns, to obtain and enforce lawful patent protection for said invention in the United States and countries foreign thereto; and vest the entire right, title and interest in and to said invention and any and all applications for letters patent therefor and letters patent thereon in to Unifrax Corporation, its successors and assigns.
