## **ASSIGNMENT**

WHEREAS, <u>Eugene R. Westerberg</u> while an employee of Quadlux, Inc. made certain inventions or discoveries (or both) set forth in an Application for Letters Patent of the United States of America filed as SERIAL NO. 08/146,415 on November 1, 1993 and titled Method And Apparatus of Cooking Food in a Lightwave Oven and signed an Assignment to Quadlux, Inc. which Assignment was originally submitted with the Application as filed.

WHEREAS, the Assignment was returned with a Notice of Non-Recordation and resubmitted for recordation December 21, 1993 and recorded December 27, 1993 at Reel/Frame 6809/0420.

WHEREAS, the title of the application was amended to read "Method of Cooking Food in a Lightwave Oven Using Visible Light Without Vaporizing All Surface Water on the Food" and the Application issued as U.S. Patent No. 5,665,259 on September 9, 1997.

WHEREAS, four divisional applications were filed based upon the Application for Patent No. 5,665,259 and on which four patents issued as No. 5,695,669 issued December 9, 1997, No. 5,712,464 issued January 27, 1998, No. 5,736,713 issued April 7, 1998 and No. 5,786,569 issued July 28, 1998, which five patents are hereinafter designated "Patents".

WHEREAS, Quadlux, Inc., a corporation of the State of California, whose current address is P.O. Box 2198, Orinda, CA 94563 and who, together with its successors and assigns, is hereinafter called "Assignee" is desirous of confirming its ownership in and acquiring the entire right, title and interest in and to said Patents together with the benefits and privileges herein recited;

NOW, THEREFORE, for valuable consideration furnished by Assignee to me, receipt and sufficiency of which I hereby acknowledge, effective nunc pro tunc as of October 28, 1993, when I signed the Declaration and Power of Attorney for the Application and signed the original Assignment, I hereby, without reservation;

- 1. Assign, transfer and convey to Assignee the entire right, title and interest together with the benefits and privileges in and to said inventions and discoveries, said Patents or similar forms of protection of the United States of America, and all other applications for Letters Patent on said inventions and discoveries in whatsoever countries, including all divisional, renewal, substitute, continuation and convention applications based in whole or in part upon said inventions or discoveries, or upon said Application, and any and all Letters Patent, reissues and extensions of said Patents or similar forms of protection granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Patents;
- 2. Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all said Patents to Assignee, as assignee of the entire right, title and interest therein, or otherwise as Assignee may direct;
- 3. Warrant that I have not knowingly conveyed to others any rights in said inventions, discoveries, applications or Patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or discoveries; and that I have good right to assign the same to Assignee without encumbrance;


