PATENT ASSIGNMENT

WHEREAS, AlphaBlox Corporation, a Delaware corporation (referred to as "AlphaBlox"), has ownership of the patent US 6,049,664 (referred to as the "Patent");

WHEREAS, International Business Machines Corporation, a New York corporation (referred to as "IBM"), is desirous of acquiring the entire right, title and interest in and to the Patent; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, AlphaBlox hereby transfers and assigns to IBM, its successors and assigns, free and clear of all liens or other encumbrances, and IBM hereby accepts the transfer and assignment of, the entire right, title and interest of AlphaBlox in and to the Patent, and all divisions, reissues, substitutions, continuations, and extensions thereof which may be granted relating to the Patent; and AlphaBlox hereby authorizes and requests the Commissioner of Patents and Trademarks or other relevant authority to issue all further patents resulting therefrom, insofar as IBM's interest is concerned, to IBM as assignee of AlphaBlox's entire right, title and interest therein.

AlphaBlox also hereby transfers and assigns to IBM, its successors and assigns, and IBM hereby accepts the transfer and assignment of, any foreign rights to the Patent, in all countries of the world, including the right to file applications and obtain patents under the terms of the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, and of the European Patent Convention, and further agrees to perform at IBM's expense, upon reasonable notice, such lawful acts and to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such foreign patent rights.

Upon the written request of IBM, AlphaBlox hereby further agrees that AlphaBlox will sign all lawful papers, execute all divisional, continuation, reissue and substitute applications, make all lawful oaths, and provide reasonable assistance to aid IBM, its successors, assigns and nominees to facilitate the prosecution of the Patent in all countries.

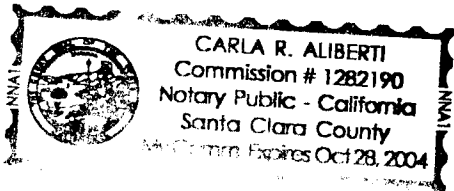
