THIS ASSIGNMENT, by Peter J. LEGG (hereinafter referred to as the assignor), residing in Swindon, Great Britain, witnesseth:

WHEREAS, said assignor has invented certain new and useful improvements in SCHEDULING DATA ACROSS A SHARED COMMUNICATION LINK IN A CELLULAR COMMUNICATION SYSTEM, set forth in an application for Letters Patent of the United States, bearing Serial No. 10/941,551 and filed on September 14, 2004; and
