ASSIGNMENT

WHEREAS, I, Hilde Angelfoss Øxseth, of Ålesund, Norway, have invented certain improvements in a CHILDREN'S SEAT, for which I filed U.S. Design Patent Application Serial No. 29/197,038 on January 5, 2004.



that I have good and full right and lawful authority to sell and convey the same in the manner herein set forth.


