ASSIGNMENT

1. Assignment.

(a) Patent Applications. Assignor does hereby assign, transfer and deliver to Assignee, and Assignee hereby receives and accepts from Assignor, the entire right, title and interest of Assignor in and throughout the United States of America, its territories and all foreign countries, in and to the inventions and discoveries as set forth in the Patent Applications, and any and all other applications which may claim priority to the Patent Applications under United States law or international convention, including, but not limited to, any non-provisionals, continuations, continuations-in-part, divisions, reissues, re-examinations, substitutions, or extensions thereof, and in and to any and all patents of the United States and foreign countries which may be issued for said inventions and discoveries, in each case, free and clear of all liens, encumbrances and security interests and claims of others. Assignor further authorizes Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries in Assignor's name or in the name of Assignee or otherwise as Assignee may deem advisable, under the international convention or otherwise.

2. Further Assurances. Without limitation to anything contained in the Subscription Agreement, Assignor shall, upon Assignee's request and at Assignee's expense, but without additional consideration to Assignor, do all reasonable acts to assure that all inventions and discoveries, and the patents and the patent application(s) contemplated by this Assignment shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by Assignor, its successors and assigns if this Assignment had not been made; and particularly to execute and deliver to Assignee all lawful application documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in

This Assignment may be executed in two or more counterparts, each of which shall constitute an original, but all of which taken together shall constitute one and the same instrument. This Assignment cannot be amended without a writing signed by each of Assignor and Assignee.

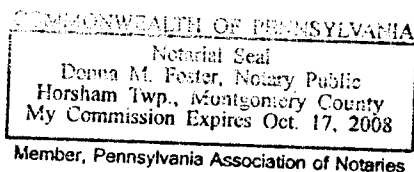

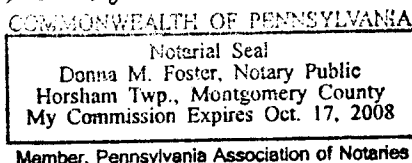
