and has executed a declaration or oath for an application for a United States patent disclosing and identifying the invention.

WHEREAS Blantec Semiconductor, Inc. (hereinafter termed "Assignee"), a corporation of the State of Delaware, having a place of business at 675 Trade Zone Blvd., Milpitas, CA 95035, wishes to acquire the entire right, title and interest in and to said application and the invention disclosed therein, and in and to all embodiments of the invention, heretofore conceived, made or discovered by said Inventor (all collectively hereinafter termed "said invention"), and in and to any and all patents, certificates of invention and other forms of protection thereon (hereinafter termed "patents") applied for or granted in the United States and/or other countries.


