WHEREAS, we, Bjørn Refsum of Ålesund, Norway, and Hilde Angelfoss Øxseth of Ålesund, Norway, have invented certain improvements in a TROLLEY, for which we filed U.S. Design Patent Application Serial No. 29/197,028 on January 5, 2004; and

WHEREAS, Stokke Gruppen AS, a Norwegian corporation, having its principal place of business in Skodje, Norway, is desirous of acquiring an interest therein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, we, Bjørn Refsum and Hilde Angelfoss Øxseth, have sold, assigned, and transferred, and do hereby sell, assign, and transfer, to Stokke Gruppen AS, its successors and assigns, the full and exclusive right to the invention in the United States and its territorial possessions and in all foreign countries, and the entire right, title, and interest in and to any and all Letters Patent that may be granted therefor in the United States and its territorial possessions and in any and all foreign countries, and in and to any and all divisions, continuations, reissues, substitutions, and extensions thereof.

We hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to Stokke Gruppen AS, as the assignee of our entire right, title, and interest in and to the same, for the sole use of Stokke Gruppen AS, and its successors and assigns.

Further, we hereby covenant and agree to and with Stokke Gruppen AS, and its successors and assigns, at the time of execution and delivery of these presents, that we are the sole and lawful owner of the entire right, title, and interest in and to the invention

and the above identified design patent application, and that the same are unencumbered, and that we have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, we agree that we will communicate to Stokke Gruppen AS, or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Stokke Gruppen AS, make all rightful oaths, and generally do everything possible to aid Stokke Gruppen AS, and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
