## ASSIGNMENT

On January 23, 2004, FirePond, Inc. ("FirePond"), a Delaware corporation, having a place of business at 8009 34<sup>th</sup> Avenue South, Suite 1050, Minneapolis, MN 55425, entered into a patent purchase agreement (the "Agreement") with Orion IP, LLC ("Orion"), a limited liability company organized under the laws of Delaware, having a place of business at 74785 Highway 111, Suite 103, Indian Wells, CA 92210.


Based upon the Agreement, FirePond hereby assigns to Orion, nunc pro tunc and effective as of January 23, 2004, the entire right, title and interest in inventions (the "Inventions") described and claimed in U.S. and foreign patents and patent application as listed on Exhibit A hereto (the "Patents"). Such right, title and interest in the Inventions and Patents, includes, without limitation:

- (i) the rights and privileges of letters patent that may be granted under any continuations, divisions, reissues, reexaminations, renewals and extensions, utility models, inventors' certificates, and designs;
- (ii) the rights to claim priority rights derived from the Patents in all countries;
- (iii) the rights to income, royalties, damages, and payments now or hereafter due or payable; and
- (iv) the right to sue, counterclaim, and recover for applicable past, present and future infringement of the Inventions or Patents.

FirePond, on behalf of itself, its successors, assigns, or other legal representatives, covenants and agrees to execute, without additional consideration, but at the expense of the Orion, such further documents deemed necessary by Orion to obtain and record title to all such patents, patent applications, or similar legal protection on the inventions in any and all countries.
