WHEREAS, Roberto GUILLEN, Francisco Javier POZUELO and Joan Matias GUERRA are inventors of an invention subject to United States Patent Application Serial No. 10/437,993 filed May, 15<sup>th</sup> 2003 and entitled "PRINTING APPARATUS AND METHOD"
