

## ASSIGNMENT OF PATENT RIGHTS

This Assignment of Patent Rights (the "Agreement") is entered into this 21 day of October 2004 (the "Effective Date"), by and between Erik S. Chan, an individual residing at 22 El Camino Moraga, Orinda, CA 94563 ("Assignor"), and Portfolio Productions, Inc. (dba Sitcom Inc.), a corporation organized under the laws of the State of California, with its principal place of business at 850 42nd Ave., Oakland, CA 94601 ("Assignee").

WHEREAS, Assignor is the owner of U.S. Patent No. D469,915 entitled "Desk Lamp" and U.S. Patent No. 6,758,585 entitled "Articulated, Adjustable Stand" (the "Assigned Patents");

WHEREAS, Assignee is desirous of acquiring the entire and exclusive right, title and interest in and to the Assigned Patents and the underlying inventions described therein, in the United States and throughout the world; and

WHEREAS, Assignor is willing to assign to Assignee all rights, title and interest in and to the Assigned Patents in the United States and throughout the world.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged by Assignor, Assignor hereby assigns, transfers and conveys to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest throughout the world in and to the Assigned Patents and the underlying inventions described therein, and any and all Letters Patent whether U.S. or foreign that are or may be granted therefrom including without limitation any extensions, continuations, continuations-in-part, divisions, reissues, reexaminations, and renewals thereof, or other equivalents thereof, and further, all rights and privileges pertaining to the Assigned Patents including, without limitation, the right, if any, to sue or bring other actions for past, present and future infringement thereof.

Assignor further agrees that Assignor will, without charge to Assignee, but at Assignee's expense: (a) cooperate with Assignee in the enforcement of the Assigned Patents; (b) execute, verify, acknowledge and deliver all such further papers, including instruments of transfer; and (c) perform such other acts as Assignee lawfully may request to obtain, maintain, defend or enforce the Assigned Patents, and to vest title thereto in Assignee, or Assignee's successors and assigns.

In the event that Assignee is unable for any reason whatsoever to secure Assignor's signature to any document it is entitled to under the preceding paragraph, Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents, as his agents and attorneys-in-fact to act for and on his behalf and instead of him, to execute and file any such document and to do all other lawfully permitted acts to further the purposes of the foregoing with the same legal force and effect as if executed by Assignee.

This Agreement shall be governed by and enforced in accordance with the laws of the State of California, without giving effect to any conflicts of law principles.

This Agreement shall be binding on, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.


