ASSIGNMENT

WHEREAS, I, Sharon G. Webber of 408 Barrington Drive, Greer, South Carolina 29650, have invented certain new and useful improvements in EDUCATIONAL DISPLAY MITT FOR MAGNETIC PLAYING PIECES AND METHOD for which a patent application executed October 29, 2004 is about to be filed; and

Further, I will communicate to Super Duper any facts known to me respecting said invention, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid said Super Duper, its successors and assigns, to obtain and enforce proper protection for said invention in the United States, and in any and all foreign countries.
