AND Assignor hereby agrees to do such things and to execute such further lawful documents and other instruments as may be necessary to perfect legal, registered and recorded title to Assignee in and to the Patent and the inventions disclosed therein; and all rights in and to any applications for patent or similar legal right, anywhere in the world, relating to the subject matter of the Patent and the inventions disclosed therein, whether now pending or later filed; and all rights in and to any patent or similar property right issuing there from.

AND Assignor does hereby covenant and agree with the Assignee that it will not execute any writing or do any act whatsoever conflicting with the terms of this Assignment document set forth herein, and that Assignor will at any time upon request, without further or additional consideration, but at the expense of the Assignee, execute such additional assignments and other writings and do such additional acts as the Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this assignment, and render all necessary assistance in making applications for and obtaining original, continuation, continuation-in-part, divisional, reissued, reexamined, and National phase patents of the U.S. or of any and all foreign countries on the inventions, and in enforcing any rights or chooses in action accruing as a result of such applications or patents, and by executing statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and shall inure to the benefit of the assigns and

legal representatives of all parties hereto.




