

And we do hereby authorize the Director of the United States Patent and Trademark Office, and any foreign counterpart to the Director, to issue any and all Letters Patent that may be granted upon any of the said applications, to the said Board of Supervisors of Louisiana State University and Agricultural and Mechanical College as the assignee of the entire interest therein.


