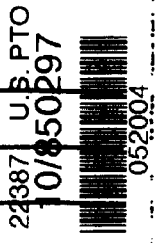

AND WE HEREBY authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said inventions or improvements to the said ISP INVESTMENTS INC., its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY covenant that we have full right to convey the entire right, title and interest herein assigned, and that we have not executed and will not execute, any agreement in conflict herewith;

AND WE HEREBY authorize and request the attorneys of record in the said application for Letters Patent to insert in the above right hand corner of this Assignment, the Serial Number and filing date of the said application when officially known;
