## ASSIGNMENT

WHEREAS, I/we, Akiyo NADAMOTO and Katsumi TANAKA, a citizen of Japan, have invented certain new and useful improvements in Related Web Contents Synchronization and Presentation System, for which I/we have executed application for Letters Patent of the United States, Serial No. 10/892,515 Filed 07/15/2004

AND I/we HEREBY covenant that I/we have full right to convey the entire interest herein assigned, and that I/we have not executed, and will not execute, any agreement in conflict herewith.

AND I/we **HEREBY** further covenant and agree that I/we will communicate to said National Institute of Information and Communications Technology, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid said National Institute of Information and Communications Technology, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
