**CERTIFICATE OF AMENDMENT
TO
AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
SPEAKOUT.COM, INC.**

**Pursuant to Section 242
of the General Corporation Law of
the State of Delaware**

Name Change from Speakout.com, Inc. to Ntercept Communications, Inc.

Speakout.com, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

FIRST: The Corporation desires to amend certain provisions contained in its charter. Therefore, pursuant to Section 242 of the General Corporation Law of the State of Delaware, this Certificate of Amendment amends certain provisions contained in the Amended and Restated Certificate of Incorporation of the Corporation dated August 11, 1999, as amended pursuant to the Certificate of Amendment dated September 17, 1999 and the Certificate of Amendment dated November 29, 2000 (the "Certificate of Incorporation").

SECOND: The name of the Corporation is Speakout.com, Inc.

THIRD: The Certificate of Incorporation of the Corporation is hereby amended from and after the date of acceptance by the Secretary of State of the State of Delaware to change the name of the Corporation as follows:

Article ONE of the Certificate of Incorporation of the Corporation shall be deleted in its entirety and the following Article ONE shall be inserted in lieu thereof:

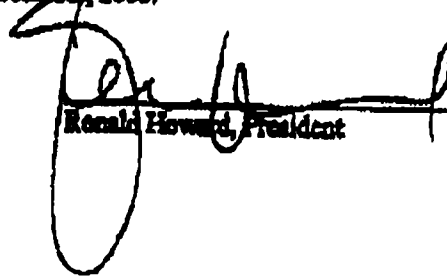
The name of the Corporation is **NTERCEPT COMMUNICATIONS, INC.**

FOURTH: This amendment to the Certificate of Incorporation was approved by the Directors of the Corporation on December 12, 2000 and declared by the Directors of the Corporation as advisable. The Directors of the Corporation directed that this amendment to the Certificate of Incorporation be submitted to the Corporation's stockholders for approval.

FIFTH: By Written Consent in lieu of a Special Meeting of the Corporation's stockholders, dated December 12, 2000, this amendment to the Certificate of Incorporation was approved.

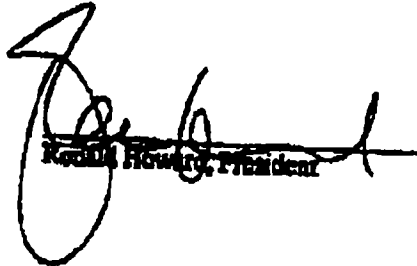
