## Patent Assignment

THIS PATENT ASSIGNMENT is made this 27th day of February, 2004 by TEAC America, Inc. a California corporation ("Assignor").

Assignor hereby requests the Commissioner of Patents and Trademarks to record Assignee, as assignee of the U.S. Patents and Patent Applications listed on Exhibit A, for the sole use and engagement of the Assignee, its successors, legal representatives and assigns.

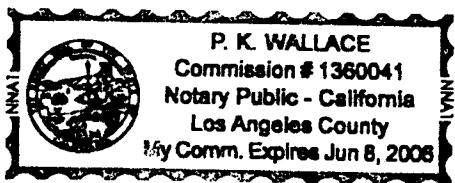
