## PURCHASE AND SALE AGREEMENT

THIS PURCHASE AND SALE AGREEMENT is made as of this 6<sup>th</sup> day of June 2003, by and among DANVILLE MATERIALS, DANVILLE MANUFACTURING, INC. and MARK S. FERNWOOD, PATRICIA FERNWOOD, THOMAS S. and ANNE S. BLAKE Trustees for the Thomas and Anne Blake Trust.

### RECITALS

WHEREAS, Seller is and has been engaged in the ownership and operation of the Business; and

WHEREAS, Seller desires to sell to Buyer, and Buyer desires to purchase, substantially all of the fixed assets, rights and properties relating to the Business, on the terms and conditions set forth in this Agreement.

NOW, THEREFORE, in consideration of the Recitals and of the mutual covenants, conditions, and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

### ARTICLE I DEFINITIONS

1.8     “Buyer” shall mean Danville Materials, a California corporation.

1.27 "Intangible Assets" shall mean all of the intangible assets owned by or licensed to Seller and used or usable in the Business, including software, software licenses, advertising formats, domain names, logos, trademarks, trade designations, service marks, trade names, patents, copyrights and applications for any of the foregoing, goodwill, advertising and promotional rights, franchise rights, telephone number(s), products under development, trade secrets, know-how, operating methods and procedures, proprietary information, processes, technical knowledge, formulae, and related rights.

1.46 "Seller" shall mean Danville Manufacturing, Inc., a California corporation.

**ARTICLE II**  
**PURCHASE AND SALE OF PURCHASED ASSETS; OTHER AGREEMENTS**

2.1 Purchase and Sale. At the Closing:


